# RESOLUTION OF THE TOWNSHIP BOARD OF BUCK CREEK TOWNSHIP, HANCOCK COUNTY, INDIANA, PERMITTING COMMUNITY SERVICE CONTRACT WITH THE VINEYARD FOOD PANTRY.

WHEREAS, IC 36-6-4-8(b) provides that with the consent of the township legislative body, the executive may contract with corporations for health and community services not specifically provided by another government entity; and,

WHEREAS, The Vineyard Food Pantry is an Indiana non-profit corporation engaged in providing the health and/or community services that are not offered by another government entity; to provide food assistance.

WHEREAS, the Trustee's and Board of Township find that the citizens of the Township are in need of the services offered by the Vineyard Food Pantry and that there is no other government entity that is designated to provide those services;

WHEREAS, the Trustee's and Board of Township find that The Vineyard Food Pantry is well-suited to address the community need of food assistance.

WHEREAS, the Trustee and the Board of Township wish to enter into a community services contract with The Vineyard Food Pantry to provide the described health and/or community services to the citizens of Buck Creek Township;

NOW, THEREFORE, BE IT RESOLVED BY THE TOWNSHIP BOARD OF BUCK CREEK TOWNSHIP, HANCOCK COUNTY, INDIANA THAT: the Trustee's are authorized to enter a Community Service Contract pursuant to IC 36-6-4-8(b) up to and not to exceed two thousand (\$2,000.00) to provide these services to citizens of Buck Creek Township and referred clients from Buck Creek Township in need of relief services, subject to all other terms and conditions provided for in a separate agreement for 2025.
